the Interior, hereby grants, assigns, transfers, conveys, and sets over unto Shell Oil Company,
a Delaware Corporation

hereinafter designated "ASSIGNEE", and ASSIGNEE'S heirs, successors, and assigns forever, that certain United States Oil and Gas Lease, Serial No. W-058196, dated June 1, 1958,
in so far as said lease covers and includes the following described land situate in Sublette
Wyoming, to-wit:
