SAID OVERRIDING ROYALTY, WHICH IS RESERVED IN THIS ASSIGNMENT, SHALL BE COMPUTED AND PAID ON THE SAME BASIS, IN THE SAME MANNER, AT THE SAME TIME AND ON THE SAME PRODUCTS, SUBSTANCES AND ELEMENTS, AS IS THE ROYALTY PAYABLE TO THE LESSOR.

ASSIGNEE SHALL HAVE THE RIGHT TO RELEASE AND SURRENDER TO THE ASSIGNOR THE OIL AND GAS LEASE HEREIN DESCRIBED, EITHER IN WHOLE OR IN PART AT ANY TIME AND FROM TIME TO TIME. HOWEVER, IF ASSIGNEE DESIRES TO SURRENDER SAID LEASE IN WHOLE OR IN PART, ASSIGNEE SHALL AT LEAST SIXTY (60) DAYS BEFORE OBLIGATION TO PAY RENT UNDER SAID LEASE WILL ARISE AND IN ANY EVENT SIXTY (60) DAYS OR MORE PRIOR TO THE EXPIRATION DATE OF SAID LEASE, NOTIFY ASSIGNOR IN WRITING BY REGISTERED MAIL OF ITS INTENTION TO DO SO, AND UPON DEMAND OF ASSIGNOR, IF MADE IN WRITING WITHIN THIRTY (30) DAYS OF RECEIPT OF SUCH NOTICE, ASSIGNEE SHALL REASSIGN TO ASSIGNOR THE INTEREST WHICH ASSIGNEE DESIRES TO RELEASE OR SURRENDER. ANY SUCH REASSIGNMENT OF THIS LEASE OR PORTION THEREOF SHALL BE FREE AND CLEAR OF ANY OVERRIDING ROYALTY, PRODUCTION PAYMENT OR OTHER BURDENS OF LIKE NATURE ASSIGNED, RESERVED, OR OTHERWISE CREATED BY, THROUGH OR UNDER ASSIGNEE.
