NOW, THEREFORE, for and in consideration of the sum of Ten and no/100 (\$10.00) and more Dollars and other good and valuable consideration in hand paid by Max L. Campbell, Leona J. Campbell, Max L. Krueger and Aliene W. Krueger, hereinafter called "Assignees", the receipt and sufficiency of which is hereby accepted by Mary Louise Tuttle, hereinafter called "Assignor", Assignor has sold, assigned, transferred and conveyed, and by these presents does sell, assign, transfer and convey unto Assignees an undivided one-fourth (1/4) interest each, as tenants in common, in and to all her right, title and interest in and to a 2% overriding royalty in all the oil and gas produced, saved and marketed from the lands hereinafter described, all pursuant to the terms and provisions of the oil and gas leases hereinafter described, to-wit:
