2. Operating Agreement (Pan Am Contract No. 49,959) dated 8-1-61 for the Big Piney "P" Sand Unit (Pan Am No. 169894) covering lands in 28-29N-112-113W as to the "P" sands. Pan American's participation is .472140, NDI .3987112.
3. Operating Agreement (Pan Am Contract No. 68,529) dated 7-1-67 for the Big Piney Mesaverde Unit (Pan Am No. 239060) covering lands in 28-29N-113W as to the Mesaverde formation. Pan American's participation is .2881 primary and .2477 secondary, NDI .2417700 primary and .20717 secondary.
