WHEREAS

in exchange for certain other lands conveyed to the United States, has selected and is entitled to a Land Patent pursuant to section 8 of the Act of June 28, 1934, as amended; 43 U.S.C. 315g (1970) for the following described lands:

NOW KNOW YE, that there is, therefore, granted by the UNITED STATES unto the above named claimant the lands above described; TO HAVE AND TO HOLD the said lands with all the rights, privileges, immunities, and appurtenances, of whatsoever nature, thereunto belonging, unto the said claimant, its successors and assigns, forever;

EXCEPTING AND RESERVING TO THE UNITED STATES:

1. A right-of-way thereon for ditches or canals constructed by the authority of the United States; and
2. All mineral deposits in the lands so patented, and to it, or persons authorized by it, the right to prospect, mine and remove such deposits from the same under applicable law.

SUBJECT TO those rights for irrigation canal purposes as have been granted to the East Fork Irrigation Company, its successors or assigns, by permit Evanston 04394, under the Act of March 3, 1891, as amended, 43 U.S.C. 946-949.
