J. Facinelli, of Sweetwater County, Wyoming, grantee, any and all right, title and interest which I or we have, or may have, in and to the estate of my late uncle, Thomas P. Facinelli, also known as Tom Facinelli, deceased, as the daughter of Rose Facinelli Anselmi, predeceased sister of said Thomas P. Facinelli, and as an heir at law, or otherwise, and particularly any and all right, title and interest which I or we have, or may have, in and to the following described real estate situated in the Counties of Lincoln, Sublette and Sweetwater, Wyoming, and we hereby also relinquish and waive all rights under and by virtue of the homestead laws of the State of Wyoming:
