they have or ought to have, in or to all the following described premises, to-wit:

Township Thirty-two (32) North, Range One Hundred Eight (108) West, Sixth
Principal Meridian, Wyoming, lying and being situated South and West of Highway
Right of Way, Highway #187, containing 3 acres, more or less.
