

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That GEORGIA M. TRAVELUTE, a single woman, grantor, of the County of Milwaukee, State of Wisconsin, for the consideration of Ten and No/100 (\$10.00) Dollars in hand paid, the receipt whereof is hereby acknowledged, hereby CONVEYS and QUIT-CLAIMS to ROBERT J. TRAVELUTE all interest in the following described real property, situate in the County of Sublette, in the State of Wyoming, to-wit:

In Township 33 North, Range 111 West of the 6th P. M.,
Sublette County, Wyoming:

Section 1: Lot 3 and 4 (also described as $N\frac{1}{2}NW\frac{1}{4}$),
 $S\frac{1}{2}NW\frac{1}{4}$ and $SW\frac{1}{4}$

Section 2: Lots 1 and 2 (also described as $N\frac{1}{2}NE\frac{1}{4}$),
Lot 3 (also described as $NE\frac{1}{4}NW\frac{1}{4}$), $S\frac{1}{2}NE\frac{1}{4}$,
 $SE\frac{1}{4}NW\frac{1}{4}$, $NE\frac{1}{4}SW\frac{1}{4}$, $SE\frac{1}{4}$, $SE\frac{1}{4}SW\frac{1}{4}$ and the follow-
ing described tract of land situated within
Lot 4, said tract being particularly de-
scribed as follows:

Beginning at a point on the north line of Section 2, Township 33 North, Range 111 West of the 6th Principal Meridian, which point lies east 422 feet from the north-west corner of Section 2 in Township 33 North, Range 111 West of the 6th P. M.; thence south, at right angles to the last described course, a distance of 327 feet to a point; thence east, at right angles to the last described course, a distance of 86 feet to a point; thence South, at right angles to the last described course, a distance of 198 feet to a point; thence east, at right angles to the last described course, a distance of 392 feet to a point; thence north, at right angles to the last described course, a distance of 525 feet to a point on the north line of said Section 2; thence west, at right angles to the last described course, and along the north line of said Section 2, a distance of 120 feet to a point; thence south at right angles to the last described course, a distance of 225 feet to a point; thence west, at right angles to the last described course, a distance of 150 feet to a point; thence north, at right angles to the last described course, a distance of 225 feet to a point on the north line of said Section 2; thence west, at right angles to the last described course and along the north line of said Section 2, a distance of 208 feet, more or less, to the point of beginning.

In Township 34 North, Range 111 West of the 6th P. M.,
Sublette County, Wyoming:

Section 35: $E\frac{1}{2}SW\frac{1}{4}$ and $S\frac{1}{2}SE\frac{1}{4}$

The Grantor further hereby CONVEYS and QUITCLAIMS to the Grantee all of her right, title and interest in and to any and all other real property lying and being within the County of Sublette, State of Wyoming, in which she may have an interest, whether or not the same is hereinabove particularly described.
