Section 14: NW $\frac{1}{4}$ , SW $\frac{1}{4}$ , Lot 2 (also described as NW $\frac{1}{4}$ NE $\frac{1}{4}$ ) and a portion of Lot 3 (also described as SW $\frac{1}{4}$ NE $\frac{1}{4}$ ) containing an area of 22.5 acres, more or less, particularly described as follows: Beginning at the legal center of Section 14, Township 32 North, Range 107 West, and proceeding thence Northerly along the West line of the NE $\frac{1}{4}$  of said Section 14, a distance of 180 feet to Point #1, the point of beginning of this traverse; thence proceeding South 89° 30' East, 401 feet to Point #2; thence proceeding North 80° East, 104 feet to Point #3; thence proceeding North 65° 30' East, 53 feet to Point #4; thence proceeding North 20° 30' East, 50 feet to Point #5; thence proceeding North 03° 30' West, 60 feet to Point #6; thence proceeding North 10° East 115 feet to Point #7; thence proceeding North 27° East, 169 feet to Point #8; thence proceeding North 28° East, 130 feet to Point #9; thence proceeding North 48° East, 142 feet to Point #10; thence proceeding North 77° 30' East, 183 feet to Point #11; thence proceeding South 75° East, 150 feet to Point #12; thence proceeding North 13° East, 122 feet to Point #13; thence proceeding North 28° East, 150 feet to Point #14; thence proceeding North 05° 30' West, 111 feet to Point #15; thence proceeding North 20° 30' East, 118 feet to Point #16; thence proceeding North 52° 30' East, 30 feet to Point #17; thence proceeding West 1304 feet, more or less, to Point #18, a point on the West line of the NE $\frac{1}{4}$  of Section 14, Township 32 North, Range 107 West; thence proceeding Southerly along the West line of the NE $\frac{1}{4}$  of said Section 14 a distance of 1108 feet, more or less, to Point #1, the point of beginning of this traverse, and excepting therefrom a portion of the SW $\frac{1}{4}$ NW $\frac{1}{4}$ , containing an area of 2.07 acres, particularly described as follows: Beginning at the West quarter corner of Section 14, Township 32 North, Range 107 West, and proceeding thence Northerly along the West line of said Section 14 a distance of 300 feet; thence proceeding Easterly at right angles to the West line of said Section 14 a distance of 300 feet; thence proceeding Southerly parallel to the West line of said Section 14 a distance of 300 feet; thence proceeding Westerly at right angles to the West line of said Section 14 a distance of 300 feet, more or less, to the West quarter corner of Section 14, Township 32 North, Range 107 West, which point is the point of beginning of this traverse.
