

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS:

That ORVENE REED, HAYDEN HUSTON and JAY JOSEPH HUSTON, of the County of Sublette, State of Wyoming, in consideration of the sum of ONE DOLLAR (\$1.00) and other good and valuable considerations to them in hand paid by JENNIE L. HUSTON, the receipt whereof is hereby confessed and acknowledged, have remised, released and forever quitclaimed and by these presents do for themselves, their heirs, executors and administrators, remise, release and forever quitclaim unto the said JENNIE L. HUSTON, her heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as they do have or ought to have, in or to all the following-described premises, situate in Sublette County and State of Wyoming, to-wit:

(a) All right, title and interest acquired by Joseph Huston in that certain quitclaim deed dated the 13th day of February, 1960, described as follows: An undivided one-half interest in and to a certain portion of the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$ NW $\frac{1}{4}$ ) of Section Two (2) in Township Thirty-three North (T 33 N) of Range One Hundred Eleven West (R 111 W) of the Sixth Principal Meridian (6th P.M.), Wyoming, bounded and particularly described as follows: Commencing at a point which is the Northwest corner of Section Two (2) and running thence East twelve hundred ninety-eight and 88/100 (1298.88) feet to a point; thence South three hundred sixty (360) feet to a point; which last mentioned point is the initial point or place of beginning. Beginning at said initial point and running thence South one hundred sixty-five (165) feet to a point; thence West two hundred (200) feet to a point; thence North along the West line one hundred sixty-five (165) feet to a point; thence East two hundred (200) feet to place of beginning. TOGETHER with all appurtenances thereunto appertaining.

(b) All of that property acquired by Joseph Huston in that certain warranty deed dated December 28, 1959, recorded January 13, 1960, Book 10 of Deeds, page 173, described as follows: Beginning at a point which is the Northwest corner of Section Two (2), Township Thirty-three (33) North, of Range One Hundred Eleven (111), West of the Sixth Principal Meridian, Wyoming, and running thence East thirteen hundred (1300) feet to a point; thence South five hundred twenty-five (525) feet to the place of beginning. Beginning at said initial point and running South one hundred eleven (111) feet to a point; thence West two hundred (200) feet to a point; thence North one hundred eleven (111) feet to a point; thence East two hundred (200) feet to place of beginning. TOGETHER with the water and water rights, buildings and any and all other improvements or hereditaments appertaining or belonging to the above-described land; and also a tract of land described as follows, to-wit: Beginning at the Government corner common to Sections Two (2), Three (3), Thirty-four (34) and Thirty-five (35), Townships Thirty-three (33) and Thirty-four (34)
