 to it in hand paid by Town of Pinedale

the receipt whereof is hereby confessed and acknowledged, ha s remised, released, and forever quitclaimed and by these presents do for itself and its heirs, executors and administrators, remise, release and forever quitclaim unto the said Town of Pinedale

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as it have or ought to have, in or to all the following described premises, to-wit:

A parcel or lot of land located in the $SE\frac{1}{4}SW\frac{1}{4}$ of Section 34, Township 34 North, Range 109 West, in Sublette County, Wyoming, and more particularly described as follows:

Beginning at point #1, which is 30 feet West and North $0^{\circ} 12'$ West, 1153.3 feet from the $S\frac{1}{4}$ corner of Section 34, above described, and located on the West boundary line of Halfmoon street; thence continuing along the West line of Halfmoon street 100 feet to point #2; thence West 50 feet to point #3; thence South $0^{\circ} 12'$ East, 100 feet to point #4; thence East 50 feet to point #1 and place of beginning and containing 5000 Sq. feet or 0.1147 acres, and lying wholly within the $SE\frac{1}{4}SW\frac{1}{4}$ of Section 34, Township 34 North, Range 109 West in Sublette County, Wyoming.
