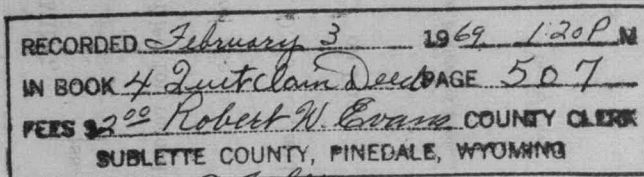
KNOW ALL MEN BY THESE PRESENTS, That MILFORD STEELE,
