 and by these presents does for himself, his heirs, executors and administrators,  
 remise, release and forever quitclaim unto the said HARRY P. SCHRIVER and KAY SCHRIVER,  
 husband and wife, and to the survivor thereof, their

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as  
 he does have or ought to have, in or to all the following described premises, to-wit:

A tract of land beginning at the northeast corner of Lot Eight (8), Cottage  
 Addition to the Town of Pinedale, Wyoming;  
 Thence west 100 feet; thence south 35 feet;  
 Thence east 100 feet; thence north 35 feet to point of beginning;  
 Being the north 35 front feet of Lot 8, Cottage Addition, comprising  
 a portion of the SE/4 SE/4 of Section 33, Township 34 North, Range 109  
 West of the 6th Principal Meridian, Wyoming, according to the United
