The Northeast Quarter Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$ ), Section Twenty-six (26), Township 33 North Range 107 West of the 6th P. M.  
TOGETHER WITH all water rights belonging thereto.
