heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as  
they have or ought to have, in or to all the following described premises, to-wit: Starting at  
the Southeast corner of the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 34, Township 34 North, Range  
109 West, and proceeding thence Northerly along the East line of the  
NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 34 a distance of 547 feet, more or less, to the point  
where the East line of the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 34 intersects the Southeast  
boundary line of the right of way for the county road; thence proceeding  
South 40°48' West along the Southeast boundary line of the right of way  
for the county road a distance of 723 feet, more or less, to the point
