and by these presents do for themselves and their heirs, executors and administrators,
remise, release and forever quitclaim unto the said BERNICE CARMICHAEL

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as
they have or ought to have, in or to all the following described premises, to-wit: Starting at
the NW corner of the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 34, Township 34 North, Range 109
West of the 6th P. M. and proceeding S 00 $^{\circ}$ 23' E, 868.8 ft. to a point
which is one foot outside the Northwest fence of the County road to
Fremont Lake; thence proceeding N 41 $^{\circ}$ 18' E, 1150.5 ft. along and one foot
outside said Northwest fence to a point on the North line of the SW $\frac{1}{4}$ NE $\frac{1}{4}$
of Section 34, Township 34 North, Range 109 West; thence proceeding


