the receipt whereof is hereby confessed and acknowledged, has remised, released, and forever quitclaimed  
 and by these presents does for itself and its heirs, executors and administrators,  
 remise, release and forever quitclaim unto the said UPPER GREEN RIVER CEMETERY DISTRICT,  
 its

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as it  
 may have or ought to have, in or to all the following described premises, to-wit:

Pinedale Cemetery according to the map of the Pinedale Cemetery and the enlarged and amended plat of the Pinedale Cemetery, as the same appears of record on the official plats thereof filed in the Office of the County Clerk and Ex-Officio Register of Deeds in the plat book at page 53 and 53-A, the same being a Subdivision of a portion of the Northeast Quarter of the Southwest Quarter of Section 34, Township 34 North, Range 109 West of the Sixth Principal Meridian, Sublette County, Wyoming.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming.

TO HAVE AND TO HOLD the said premises unto the said  
 UPPER GREEN RIVER CEMETERY DISTRICT, its  
 heirs and assigns, to his and their own proper use and behoof forever. So that neither  
 the TOWN OF PINEDALE  
 nor any other person in its name or behalf, or either of us or any other person in our or either of our names or behalf shall or will hereafter claim or demand any right or title to the premises or any part thereof, but they and every one of them shall by these presents be excluded and forever barred.
