

WARRANT DEED

KNOW ALL MEN BY THESE PRESENTS, that CROSS LAZY TWO LAND AND LIVESTOCK COMPANY, a Wyoming Corporation, Grantor herein,

in consideration of the sum of TEN DOLLARS (\$10.00) and other values - - - - - DOLLARS to it in hand paid by CLIFFORD P. DANIELS and SOPHIE M. DANIELS, husband and wife,

the receipt whereof is hereby confessed and acknowledged, he has received, released, and forever quitclaimed and by these presents does for its heirs, executors and administrators, release and forever quitclaim to the said CLIFFORD P. DANIELS and SOPHIE M. DANIELS, husband and wife, their

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as it have or ought to have, in or to all the following described premises, to-wit:
