heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as
 he has ~~have~~ or ought to have, in or to all the following described premises, to-wit:

All of Tract Numbered Seven (7) in the Milleg Heights Subdivision as the same
 appears of record in the office of the Clerk of Sublette County, Wyoming, and
 according to the plat and map thereof which is a matter of public record in
 the office of the Clerk of Sublette County, Wyoming, and together with all

 rights of ingress and egress and to the use of Milleg Lane at all times; and
