may have or ought to have, in or to all the following described premises, to-wit:

That part of the SW $\frac{1}{4}$ NW $\frac{1}{4}$  Section 5, Township 32 North, Range  
108 West, 6th Principal Meridian being on the southerly side  
of Wyoming State Highway U. S. 187, containing 4.6 acres,  
more or less, together with all water, water rights, ditch,  
ditch rights and improvements and appurtenances thereunto  
appertaining.

SUBJECT TO reservations contained in United States Patents  
and to easements and rights of way of record or in use.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the  
State of Wyoming.
