heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as they  
have or ought to have, in or to all the following described premises, to-wit:

Lot 8, Block 2, Cooley Eighth Addition to the Town of Pinedale, as  
the same appears of record on the map or plat thereof filed in the  
Office of the County Clerk and Ex-Officio Register of Deeds for Sub-  
lette County, Wyoming, together with all improvements and appurten-  
ances thereunto appertaining; SUBJECT TO reservations and restric-  
tions contained in United States Patents and to easements and rights  
of way of record or in use; and SUBJECT TO Restrictions and Cove-  
nants Running with the land on the Cooley Eighth Addition to the  
Town of Pinedale, Wyoming recorded in Book 29 of Miscellaneous on  
June 27, 1973, in the Office of the County Clerk.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the
