

QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That George R. Mackey, Jr.,

the receipt whereof is hereby confessed and acknowledged, has remised, released, and forever quitclaimed
 and by these presents does for himself, his heirs, executors and administrators,
 remise, release and forever quitclaim unto the said Mary Lou Mackey, his wife,

her heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as he
shall have or ought to have, in or to all the following described premises, to-wit:

A tract of land beginning at the northeast corner of Lot 8,
 Cottage Addition to the Town of Pinedale, Sublette County,
 Wyoming; thence West 100 feet; thence South 35 feet; thence
 East 100 feet; thence North 35 feet to the point of beginning;
 being the North 35 feet of Lot 8, Cottage Addition to the
 Town of Pinedale, Sublette County, Wyoming, comprising a portion
 of the SE/4SE/4 of Section 33, Township 34 North, Range 109
 West of the 6th P.M., together with all improvements thereon,
 and easements, appurtenances and incidents belonging or
 appertaining thereto, or used in connection therewith; subject,
 however, to all mining, mineral and other exceptions, reserva-
 tions, covenants, subsidence, conditions and rights of way of record.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the
 State of Wyoming.

 of, but they and every one of them shall by these presents be excluded and forever barred.
