ditch rights, reservoir and reservoir rights;

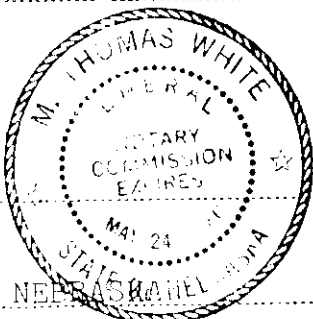
SUBJECT TO reservations and restrictions contained in United States
