the receipt whereof is hereby confessed and acknowledged, have remised, released, and forever quitclaimed
 and by these presents do for themselves and their heirs, executors and administrators,
 remis, release and forever quitclaim unto the said GORDON E. STEELE and DONNA M. STEELE,
husband and wife, their

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as
 they have or ought to have, in or to all the following described premises, to-wit:

The Boulder Mercantile Store and residence, and
 approximately five (5) acres of land located at the
 intersection of State Highway 187 and the East Fork
 Road, said five (5) acres described as follows:

A tract of land located in the NE1/4 of Section 16, T32N, R108W,
 of the 6th P.M., Sublette County, Wyoming and more particularly
 described as follows: Beginning at a point on the west right-of-
 way of Wyoming State Highway 353, said point bears S45°09'27.8"W,
 a distance of 1850.53 feet from the northeast section corner of
 said Section 16; thence from said point of beginning S53°14'36"W,
 along said west right-of-way, a distance of 278.10 feet to a point
 on the northeast right-of-way of U.S. Highway 187; thence

 southeast boundary of Kirk property, a distance of 99.71 feet;

 the northwest boundary of Kirk property, a distance of 91.27 feet
 to a point on the northeast right-of-way of U.S. 187; thence
 N45°19'24"W, along said right-of-way, a distance of 60.07 feet,
 more or less; thence N44°40'36"E, a distance of 25.00 feet; thence
 N45°19'24"W, along said right-of-way, a distance of 522.30 feet,
 more or less; thence N44°30'36"E, a distance of 198.78 feet;
 thence S45°19'24"E, a distance of 215.93 feet; thence South a
 distance of 150.0 feet; thence East, a distance of 150.0 feet; (cont)
