the receipt whereof is hereby confessed and acknowledged, have remised, released, and forever quitclaimed and by these presents do for themselves and their heirs, executors and administrators, remis, release and forever quitclaim unto the said ROBERT W. SIEVERS, a married man, as his sole and separate property, his

heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as

have or ought to have, in or to all the following described premises, to-wit:

A tract of land located in the N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 36, T38N, R110W of the 6th P.M., Sublette County, Wyoming and more particularly described as follows:

BEGINNING at a point which bears N01°15'E, a distance of 382.0 feet from the southwest corner of said N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence from said point of beginning continue N01°15'E along the west boundary of said N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ , a distance of 282.6 feet, more or less; thence N89°50'E along the north boundary of said N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ , a distance of 813.80 feet, more or less; thence S30°37'E along the west right of way line of State Highway 352, a distance of 542.37 feet, more or less; thence N80°33'W, a distance of 1111.21 feet, more or less, to the point of beginning; said tract contained 7.93 acres, more or less.

heirs and assigns, to his and their own proper use and behoof forever. So that neither ROBERT W. SIEVERS and DONNA E. SIEVERS, husband and wife,

nor any other person in their name or behalf, or either of us or any other person in our or either of our names or behalf shall or will hereafter claim or demand any right or title to the premises or any part thereof, but they and every one of them shall by these presents be excluded and forever barred.
