MING, grantee, the following described real estate, situated in the County of Sublette, State of Wyoming,  
to-wit:

All that portion of a tract of land described in Book 40, Miscellaneous, at  
Page 699 of the Sublette County Records, located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$  of Section  
8, T. 32 N., R. 108 W. of the 6th P.M., Wyoming, lying northeasterly of a parallel  
right-of-way line 75 feet to the left or southwesterly side when measured radially to  
the following described survey line of highway, said parallel right-of-way line  
begins on the east boundary of said Section 8 and ends on the southeasterly boundary  
of Lot 2 of Big River Subdivision, as platted and described in Book 37,  
Miscellaneous, at Page 563 of the Sublette County Records:

Commencing at the northeast corner of said Section 8;

thence S.00°39'56.2"W. along the east boundary of said Section 8 a distance of  
1,571.07 feet to a point on said survey line of highway;

thence S.36°33'30.6"E. a distance of 99.37 feet to a point on said survey line  
of highway, the True Point of Beginning, said point of beginning also being located  
on a 1°00'00" circular curve concave to the southwest, the radius of which is  
5,729.58 feet and at which point a line tangent to said curve bears N.36°03'42.0"E.;

thence northeasterly along said curve through a central angle of 4°15' a  
distance of 425 feet, more or less, until said parallel right-of-way line intersects  
the easterly boundary of said Lot 2.

EXCEPTING and EXCLUDING from the above described parcel of land any portion of a  
tract of land as described in Book 7, Q.C.D., at Page 172 of the Sublette County  
Records.

The parcel of land hereby conveyed contains 0.48 acres, more or less.

NOTE: All bearings and distances in this description are based on the Wyoming State  
Plane Coordinate System, West Zone, modified to Wyoming Highway Department Coordinate  
System by an adjustment factor of 1.0004.

Excepting and reserving from the above described lands and unto the grantors  
herein all oil, gas, minerals and mineral estate of every kind and nature that can be  
removed from the ground without jeopardy to the maintenance or safety of public use  
or travel upon the surface estate hereby granted and without using the surface of the  
lands hereby granted.
