West Half of Southwest Quarter of Northwest Quarter ( $W\frac{1}{2}SW\frac{1}{4}NW\frac{1}{4}$ ), Section 1, Township 34 North, Range 113 West of the 6th P.M., containing 20 acres, more or less; SUBJECT TO all reservations, easements and restrictions of record.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Wyoming.

TO HAVE AND TO HOLD the said premises unto the said CORA E. ROBERTS, her heirs and assigns, to her own proper use and benefit forever. 
