

Resolution

Whereas, the Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Forty Rod Road No. 23-149. Described as follows:

Beginning at Station 0+00 on the center-line of the Green-River Road N63°-25'W, 512.2' from the east one-quarter corner of Section 20, T35N, R110W, Sublette County, Wyoming

And thence Westerly through the following:

T35N R110W  
Section 20-SE $\frac{1}{4}$ NE $\frac{1}{4}$ , N $\frac{1}{2}$ SE $\frac{1}{4}$ , E $\frac{1}{2}$ SW $\frac{1}{4}$ , SW $\frac{1}{4}$ SW $\frac{1}{4}$   
Section 19-S $\frac{1}{2}$ SE $\frac{1}{4}$ , S $\frac{1}{2}$ SW $\frac{1}{4}$

T35N R111W  
Section 24-S $\frac{1}{2}$ SE $\frac{1}{4}$ , S $\frac{1}{2}$ SW $\frac{1}{4}$ , NW $\frac{1}{4}$ SW $\frac{1}{4}$   
Section 23-S $\frac{1}{2}$   
Section 22-N $\frac{1}{2}$ S $\frac{1}{2}$

And terminating at a point on the center-line of U.S. Highway 189 S57°-08'E 1231.8' from the W $\frac{1}{2}$  corner of Section 22, T35N, R11W.

These points are shown on the linen filed in the County Clerks Office of Sublette County.

Whereas, right-of-way easements have been secured from Eugene Pfisterer, Ben F. Malquist et ux, Harold Reach et ux, Harvey Stone et ux, C.C. Feltner et ux, Richard L. Thompson et ux, as owners of the only patented lands.

NOW THEREFORE, BE IT RESOLVED, that the Forty Rod Road No. 23-149 as described above, be and it hereby is declared established as a public Road.
