

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Green River Stock Driveway County Road, Project Number 23-107, described as follows:

Beginning at a point s89°-19'W, 431 feet from the southeast corner of Section 16, T34N, R110W, Sublette County, Wyoming; thence Northerly, along the easterly line of said Section 16 to the northeast corner; thence Easterly, along the south line of the SW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 10 to the westerly right-of-way line of State Secondary Highway No. 1802; thence Northerly parallel to and alongside of the westerly right-of-way line of said highway and extension through the NW $\frac{1}{4}$ SW $\frac{1}{4}$ and W $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 10; NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 9; the E $\frac{1}{2}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, and Lots 2 and 3 of Section 4, T34N, R110W, and the E $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 33, T35N, R110W to a terminus at the center one-quarter of said Section 33.

WHEREAS, right of way easements have been secured from Carroll R. Noble as owner of the only patented land.

NOW, THEREFORE, BE IT RESOLVED, That the Green River Stock Driveway County Road, Project Number 23-107 as described above, be and it hereby is declared established as a public road.
