

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Cottonwood Merna County Road No. 23-116 described as follows:

Beginning at Station 0+00 in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 2, T33N R113W, N36 degrees - 07'E, 576 feet from the south one-quarter corner of Section 2, T33N, R113W.

Thence running northerly through the following:

T33N R113W

Section 2 - W $\frac{1}{2}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, E $\frac{1}{2}$ NW $\frac{1}{4}$

T34N R113W

Section 35 - E $\frac{1}{2}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ NE $\frac{1}{4}$

Section 26 - SE $\frac{1}{4}$ SE $\frac{1}{4}$

Section 25 - W $\frac{1}{2}$ SW $\frac{1}{4}$, W $\frac{1}{2}$ NW $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$

Section 24 - SE $\frac{1}{4}$ SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$, E $\frac{1}{2}$ NE $\frac{1}{4}$

Section 13 - E $\frac{1}{2}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, E $\frac{1}{2}$ NW $\frac{1}{4}$

Section 12 - E $\frac{1}{2}$ W $\frac{1}{2}$, W $\frac{1}{2}$ NE $\frac{1}{4}$

Section 1 - E $\frac{1}{2}$ SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$

And terminating at the center of the one-quarter corner of Section 1, T34N, R113W.

WHEREAS, right-of-way easements have been secured from Stanley G. Murdock and Thomas C. Murdock, Mayme E. Ball, Dorthean Jorgensen, as owners of the only patented lands.

WHEREAS, an affidavit for right-of-way has been filed and granted by the Land Office in Cheyenne, Wyoming for all Federally owned lands.

NOW, THEREFORE, BE IT RESOLVED, that the Cottonwood Merna County Road No. 23-116 as described above, be and it hereby is declared established as a public road.
