

RESOLUTION

WHEREAS, The Board of County Commissioners of Sublette County, Wyoming, deem the public interest requires that a road be established to be known as the Middle Piney County Road No. 23-111 described as follows:

Commencing at Station 286+50.0 of State Highway No. 350, N86°-58'W, 532.3 feet from the East one-quarter corner of Section 32, T30N, R112W.

Thence Westerly through the following:

T30N R112W

Section 32 - SE $\frac{1}{4}$ NE $\frac{1}{4}$ , N $\frac{1}{2}$ S $\frac{1}{2}$ , SW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 31 - NE $\frac{1}{4}$ SE $\frac{1}{4}$ , S $\frac{1}{2}$ S $\frac{1}{2}$

T30N R113W

Section 36 - S $\frac{1}{2}$ S $\frac{1}{2}$

Section 35 - S $\frac{1}{2}$ S $\frac{1}{2}$

Section 34 - S $\frac{1}{2}$ S $\frac{1}{2}$ , NW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 33 - E $\frac{1}{2}$ SE $\frac{1}{4}$ , NW $\frac{1}{4}$ SE $\frac{1}{4}$ , SW $\frac{1}{4}$ NE $\frac{1}{4}$

And terminating at Station 573+00.0, N88°-43'W, 2340 feet from the East one-quarter corner of Section 33, T30N, R113W.

WHEREAS, right-of-way easements have been secured from the State of Wyoming, Koshland Trust, Dan H. Budd, Miller Land and Livestock, Payson W. Spaulding and the Reservoir Ranch Company as owners of the only patented lands.

WHEREAS, an affidavit for right-of-way has been filed and granted by the Land Office in Cheyenne for all Federally owned lands.

NOW, THEREFORE, BE IT RESOLVED, that the Middle Piney County Road No. 23-111 as described above, be and it hereby is declared established as a public road.
