

WHEREAS, the resolution for the Muddy Speedway Road No. 23-113 adopted by the Board of County Commissioners on April 1, 1969, contains several discrepancies, Lois E. Cobb moves that the following resolution be adopted as an amended or substitute resolution to ameliorate the foregoing discrepancies:

RESOLUTION

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section 24-3-108, to be known as the MUDDY SPEEDWAY COUNTY ROAD NO. 23-113, described as follows:

Beginning at Station 20+2900 on the east line of Section 32, T31N, R106W, Sublette County, Wyoming, South 1620 feet from the northeast corner of said Section 32;

thence, running Southerly and Westerly through the following:

and terminating at Station 42+2240 on the east right-of-way line of U.S. Highway No. 187, S26°53'W, 2720 feet from the north one-quarter corner of Section 21, T30N, R107W.

WHEREAS, right-of-way easements have been secured from the following:

- 2). Paul Zembo Jr. et al

WHEREAS, a right-of-way easement has been granted by the Bureau of Land Management for public lands of the United States of America lying within this road;

WHEREAS, the official linen plat consisting of three sheets for this road is filed in the Office of the Clerk of Sublette County;

NOW, therefore be it resolved, that the MUDDY SPEEDWAY COUNTY ROAD NO. 23-113 described above, be and is hereby declared a public County Road.
