

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Sublette County deems the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section 24-3-108, to be known as SCAB CREEK COUNTY ROAD NO. 23-122 described as follows:

Beginning at Station 0+00, within the right-of-way for Wyoming State Highway 353, S27°-11'-50"W, a distance of 2096.22 feet from the east one-quarter corner of Section 9, T32N, R107W, Sublette County, Wyoming;

thence running Easterly and Northerly through the following:

T32N, R107W

Section 9 - E $\frac{1}{2}$ SE $\frac{1}{4}$

Section 10 - N $\frac{1}{2}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, N $\frac{1}{2}$ NE $\frac{1}{4}$

Section 11 - N $\frac{1}{2}$ NW $\frac{1}{4}$, NW $\frac{1}{4}$ NE $\frac{1}{4}$

Section 2 - S $\frac{1}{2}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$

and terminating at the northeast corner of Lot 2 of said Section 11, East, 3960 feet from the northwest corner of said section.

WHEREAS, a right-of-way easement has been granted by the Bureau of Land Management for public lands of the United States of America lying within the road;

WHEREAS, the official linen plat consisting of one sheet for this road is filed in the Office of the Clerk of Sublette County;


