

R E S O L U T I O N

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF GARY AND JUDITH GREGORY, MICHAEL D. AND LAURIE JO McCLAIN, AND HARVEY NORRIS FOR A ZONE CHANGE FROM A-1 to R-R OF CERTAIN LANDS SITUATED IN SUBLETTE COUNTY, WYOMING.

WHEREAS, Gary and Judith Gregory, Michael D. and Laurie Jo McClain, and Harvey Norris filed an application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 27, T34N, R110W of the 6th P.M., Sublette County, Wyoming, from A-1 to R-R.

WHEREAS, a notice of a public hearing on said application before said Commission was published in the Pinedale Roundup on January 14, 1982 and February 11, 1982.

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m., on February 18, 1982, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that said application be approved.

WHEREAS, a notice of a public hearing on said application before the Board of Commissioners of Sublette County was published in the Pinedale Roundup on March 11, 1982 and April 8, 1982.

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 2:00 p.m., on April 13, 1982, at which time said Board determined it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Gary and Judith Gregory, Michael D. and Laurie Jo McClain, and Harvey Norris for a zone change and reclassification from A-1 to R-R of approximately 13.35 acres in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 27, T34N, R110W of the 6th P.M., Sublette County, Wyoming, be and the same is hereby approved.
