S. 2477, (43 USC 932); and

THEREFORE, BE IT FURTHER RESOLVED, that the Board of County Commissioners authorize the County Surveyor to prepare the plats and other necessary documents to make application to the Bureau of Land Management to file and have the records note that the foregoing public road was established under authority of R. S. 2477 (43 USC 932).


