

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Sublette deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977 as amended, Section 24-3-108, to be known as the PRICE -- TODD COUNTY ROAD NO. 23-187 and described as follows:

BEGINNING at the intersection with the DeSmet County Road No. 23-188 in the NW $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 12, T33N, R111W;

thence Southeasterly through the following:

T33N, R111W

Section 12 -- NW $\frac{1}{4}$ W $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ SE $\frac{1}{4}$

Section 13 -- NE $\frac{1}{4}$ NE $\frac{1}{4}$

T33N, R110W

Section 18 -- Lot 1 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), NE $\frac{1}{4}$ NW $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$

Section 17 -- NW $\frac{1}{4}$ SW $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, SE $\frac{1}{4}$ SE $\frac{1}{4}$

Section 20 -- NE $\frac{1}{4}$ NE $\frac{1}{4}$

and terminating on the east line of the said NE $\frac{1}{4}$ NE $\frac{1}{4}$ at a point S00°-04'E, 200 feet, more or less, from the northeast corner of said Section 20;

WHEREAS, a right-of-way has been granted by the United States of America acting through the Bureau of Land Management dated 28 September 1982 bearing serial number W-81005;

WHEREAS, the said roadway has been surveyed, mapped, and constructed to standards of the County of Sublette;

WHEREAS, the official linen plat consisting of one sheet for this roadway is filed in the Office of the Clerk of Sublette County;

NOW, THEREFORE BE IT RESOLVED, that the PRICE -- TODD COUNTY ROAD NO. 23-187 as described above, be and is hereby declared a public County Road.
