

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section 24-3-108 and Section 24-1-101, to be known as GRABLE LANE COUNTY ROAD NO. 23-124 described as follows:

Beginning at a point on the east right-of-way line of U.S. Highway 187, N86°-12'-22.4"E, 94.35 feet from the southwest corner of Section 15, T32N, R108W, Sublette County, Wyoming; thence running Easterly and Southerly through the following:

T32N, R108W

and terminating at a point S00°-07'-30.0"W, 18 feet from the southwest corner of said Section 24.
