

R E S O L U T I O N

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF JOHN C. AND LINDA K. FRAZIER, CURT A. AND MARCIA A. THOMPSON, A.G. ANDRIKOPOULOS AND L.V. BOCKIUS FOR A ZONE CHANGE FROM A-1 TO R-R 5 SITUATED IN SECTIONS 24 AND 25, T37N, R110W, 6th P.M., SUBLETTE COUNTY, WYOMING.

WHEREAS, John C. and Linda K. Frazier, Curt A. and Marcia A. Thompson, A.G. Andrikopoulos and L.V. Bockius filed an application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to R-R 5 being part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ and the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 25, part of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 24, all in T37N, R110W, lying to the south and east of State Highway 352 in Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on December 17, 1981, January 14 and September 16, 1982;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on September 23, 1982, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that said application be approved with the stipulation that the development be a planned unit development as stated on the application for zoning amendment;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on October 7 and November 3, 1982;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 4:00 p.m. on November 9, 1982, at which time said Board determined it would accept and follow the recommendations of the Planning and Zoning Commission and approve said application with said stipulation.

NOW, THEREFORE, BE IT RESOLVED:

That the application of John C. and Linda K. Frazier, Curt A. and Marcia A. Thompson, A.G. Andrikopoulos and L.V. Bockius for a zone change from A-1 to R-R 5 of approximately 50 acres being part of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ and the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 25, part of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 24, all in T37N, R110W, lying to the south and east of State Highway 352 in Sublette County, Wyoming, is hereby approved.
