

RESOLUTION NO. 83-7B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF MICHAEL S. LOONEY AND KATHERINE M. LOONEY FOR A ZONE CHANGE FROM A-1 TO I-L OF CERTAIN LANDS SITUATED IN SECTIONS 32 AND 33, T27N, R113W, 6th P.M., SUBLETTE COUNTY, WYOMING.

WHEREAS, Michael S. Looney and Katherine M. Looney filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to I-L, 120 acres, more or less, being the S $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 33 and the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 32, T27N, R113W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on December 2 and 30, 1982;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on January 6, 1983, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on January 13 and February 10, 1983;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m., on February 15, 1983, at which time said Board determined it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Michael S. Looney and Katherine M. Looney for a zone change from A-1 to I-L of 120 acres, more or less, being the S $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 33 and the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 32, T27N, R113W, Sublette County, Wyoming, is hereby approved.
