

RESOLUTION NO. 83-26B

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section 24-3-108 and Section 24-1-101, to be known as the PINEDALE SOUTH COUNTY ROAD NO. 23-123 described as follows:

BEGINNING at a point which is South, a distance of 9.32 feet of a point which is S89°-12'-41.2"W, a distance of 60.00 feet from the W1/16 corner common to Sections 9 and 16, T33N, R109W; thence running Easterly and Northerly through the following:

T33N, R109W

Section 9 -- SE $\frac{1}{4}$ SW $\frac{1}{4}$ , SW $\frac{1}{4}$ SE $\frac{1}{4}$ , E $\frac{1}{2}$ E $\frac{1}{2}$   
Section 16 -- NE $\frac{1}{4}$ NW $\frac{1}{4}$ , N $\frac{1}{2}$ NE $\frac{1}{4}$   
Section 10 -- W $\frac{1}{2}$ W $\frac{1}{2}$   
Section 4 -- E $\frac{1}{2}$ SE $\frac{1}{4}$ , SE $\frac{1}{4}$ NE $\frac{1}{4}$   
Section 3 -- W $\frac{1}{2}$ SW $\frac{1}{4}$ , SW $\frac{1}{4}$ NW $\frac{1}{4}$

and terminating at a point which bears S83°-28'-41.5"E, a distance of 6.72 feet from a point which bears N00°-00'-42.5"W, a distance of 382.15 feet from the west quarter corner of said Section 3.

WHEREAS, a right-of-way easement for the Pinedale South County Road No. 23-123 was dedicated on the Amended Plat for Arrowhead Subdivision;

WHEREAS, a deed was given to the County of Sublette by Elton Cooley for lands within the Pinedale South County Road No. 23-123 right of way;

WHEREAS, for lands of F.J. and Christine Mollring, David E. Schaffer, and Lucius Morgan, procedures were followed as defined in Wyoming Statutes, 1977, as amended, Section 24-1-101, including preparation of a map, advertisement in the Pinedale Roundup, notification of owners by certified mail, and public hearing held by the Board of County Commissioners of Sublette County at 1:00 p.m. on the 5th day of April, 1983, at which time having received no written or verbal protest, the Board by resolution did adversely possess said right of way;

WHEREAS, a right-of-way easement has been granted by the Board of Land Commissioners of the State of Wyoming for public lands of the State of Wyoming lying within this road;
