

RESOLUTION NO. 83-27B

WHEREAS, the Board of County Commissioners of Sublette County deem the public interest requires that a road be established in accordance with Wyoming Statutes, 1977, as amended, Section 24-3-108, to be known as the NEW FORK WILLOW CREEK COUNTY ROAD NO. 23-120 described as follows:

BEGINNING at Station 0+00, S42°-19.6'E, a distance of 556.57 feet from the west one quarter corner of Section 21, T35N, R110W; thence running Northerly, Northeasterly, and Easterly through the following:

T35N, R110W

Section 21 -- N $\frac{1}{2}$ SW $\frac{1}{4}$, E $\frac{1}{2}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ NE $\frac{1}{4}$
Section 16 -- S $\frac{1}{2}$ SE $\frac{1}{4}$
Section 15 -- SW $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, W $\frac{1}{2}$ NE $\frac{1}{4}$
Section 10 -- S $\frac{1}{2}$ SE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 11 -- NW $\frac{1}{4}$ SE $\frac{1}{4}$, W $\frac{1}{2}$ NW $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$
Section 2 -- SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$
Section 1 -- NW $\frac{1}{4}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$

and terminating at Station 292+88.49 in Lot 3 (NE $\frac{1}{4}$ NW $\frac{1}{4}$) of said Section 1, S86°-48.0'E, a distance of 2069.40 feet, more or less, from the northwest corner of said Section 1.

WHEREAS, a right-of-way easement has been secured from John Welborn, Larry and Sharon Lozier, and Bar Cross Land and Livestock;

WHEREAS, a right-of-way easement has been granted by the Board of Land Commissioners of the State of Wyoming for public lands of the State of Wyoming lying within the road;

WHEREAS, the official linen plat consisting of 1 sheet for this road is filed in the Office of the Clerk of Sublette County;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SUBLINTE COUNTY, WYOMING:

That the NEW FORK WILLOW CREEK COUNTY ROAD NO. 23-120 described above, be and is hereby declared a public County Road.
