

R E S O L U T I O N N O . 83- 32B

A RESOLUTION AUTHORIZING THE EXPENDITURE OF \$15,000.00 OUT OF REVENUE SHARING FUNDS TO MEET THE DOWN PAYMENT ON THE PURCHASING OF A FIRE TRUCK FOR USE BY THE PINEDALE VOLUNTEER FIRE DEPARTMENT, AUTHORIZING THE FINANCING OF THE BALANCE OF THE PURCHASE PRICE THROUGH THE FIRST NATIONAL BANK OF PINEDALE, AND DIRECTING THE CHAIRMAN TO EXECUTE ALL REQUIRED LOAN DOCUMENTS.

WHEREAS, the Pinedale Volunteer Fire Department entered into a contract to purchase the following: One (1) new Spartan Custom fire truck, CFC 2000, all wheel drive chassis, Emergency One Protector IV top mount fire apparatus, together with body apparatus and equipment contained in specifications dated 9/16/82 submitted by Becker Fire Equipment Co., 1717 East Yellowstone, Casper, Wyoming 82601 for the total sum of: One Hundred Fifty Eight Thousand Five Hundred Fifty-Nine Dollars and 00/100 (\$158,559.00), and the County expected that the Town of Pinedale would equally share the cost of purchase with the County.

WHEREAS, the Town of Pinedale has informed the County that it is presently unable to contribute anything toward the down payment that is now due and payable, nor to assume any responsibility for its purchase.

WHEREAS, in order to maintain proper adequate fire protection for all residents in the northern fire district, the County finds it necessary as an emergency measure to assist the Pinedale Volunteer Fire Department in acquiring the new fire truck.

WHEREAS, the Pinedale Volunteer Fire Department has the sum of \$15,000.00, which it is willing to contribute toward the required down payment.

WHEREAS, the County is willing to expend the sum of \$15,000.00 from its revenue sharing account in order to meet the down payment requirement.

WHEREAS, the County finds that it has been unwittingly placed in a position where it has to assume full responsibility for the purchase of the fire truck, and it does so with the expectation that the Town of Pinedale will eventually participate to the best of its ability on a fair-share basis.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING:

1. That the sum of \$15,000.00 shall be expended from the revenue sharing account and combined with the \$15,000.00 held by the Pinedale Volunteer Fire Department to meet the down payment requirement of \$30,000.00.

2. That the County shall purchase the fire truck in its own name, for use by the Pinedale Volunteer Fire Department and such other use as may be directed by the County.

3. That the County shall assume initial responsibility for payment of said fire truck, and shall negotiate with the First National Bank of Pinedale for appropriate financing terms.

4. That the Chairman of the Board is authorized and directed to execute all instruments required to accomplish such financing.

5. That the purchase shall be financed by mill levy, in such sums as may be required to be paid, considering that at some future date the Town of Pinedale
