

RESOLUTION NO. 83-48B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF WILFRED J. O'NEAL FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 TO R-R 10 USE OF CERTAIN LANDS SITUATED IN SECTION 2, T33N, R111W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Wilfred J. O'Neal filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to R-R 10 use, 10 acres, more or less, in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 2, T33N, R111W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on March 31 and April 28, 1983;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on May 5, 1983, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on May 12 and June 16, 1983;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on June 21, 1983, at which time said application was tabled until legal access to said lands was obtained;

WHEREAS, a notice of public hearing on said application before said Board of County Commissioners was published in the Pinedale Roundup on August 11, 1983;

WHEREAS, pursuant to said published notice continuation of the public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on August 16, 1983, at which time said Board determined that legal access to said lands had been obtained from the Bureau of Land Management and that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Wilfred J. O'Neal for a zoning district boundary change from A-1 to R-R 10 use for 10 acres, more or less, in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 2, T33N, R111W, Sublette County, Wyoming, is hereby approved.
