

RESOLUTION NO. 83-51B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF STANLEY J. BIRGE FOR A ZONING DISTRICT BOUNDARY CHANGE FROM RC TO A-1 USE OF CERTAIN LANDS SITUATED IN SECTION 2, T39N, R110W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Stanley J. and Claire H. Birge filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from RC to A-1 being the SE $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 2, T39N, R110W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on June 30 and July 28, 1983;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on August 4, 1983, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on August 11 and September 15, 1983;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on September 20, 1983, at which time said Board determined it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Stanley J. and Claire H. Birge for a zone change from RC to A-1 of 40 acres being the SE $\frac{1}{4}$ NE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 2, T39N, R110W, Sublette County, Wyoming, is hereby approved.
