RESOLUTION NO. 83-52B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF MILT AND DONNA SCHILLING FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 TO R-R 10 USE OF CERTAIN LANDS SITUATED IN SECTION 34, T31N, R111W, AND FROM A-1 TO R-R 5 USE OF CERTAIN LANDS SITUATED IN SECTION 34, T31N, R111W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Milt and Donna Schilling filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to R-R 5 being the S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$ , Section 34, T31N, R111W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on June 30 and July 28, 1983;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on August 4, 1983, at which time Milt Schilling amended his application to the following:

To reclassify and rezone that portion of the said S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$  lying to the west of Muddy Creek County Road to R-R 10, and to reclassify and rezone the remaining portion of said S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$  lying to the east of said road to R-R 5 use.

The Commission determined that it would recommend to the Board of County Commissioners of Sublette County that the application be approved as amended;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on August 11 and September 15, 1983;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on September 20, 1983, at which time said Board determined it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application as amended.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Milt and Donna Schilling for a zone change from A-1 to R-R 10 of 12.9± acres being that portion of the S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 34, T31N, R111W lying to the west of Muddy Creek County Road, and a zone change from A-1 to R-R 5 of 7.13 acres being that portion of the S $\frac{1}{2}$ SW $\frac{1}{4}$ SW $\frac{1}{4}$  of said Section 34 lying to the east of said county road, in Sublette County, Wyoming, is hereby approved.
