

## RESOLUTION NO. 84-65B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF DAVE L. AND BEVERLY J. HAWKS AND CONWAY D. AND GLORIA HAWKS FOR A ZONING DISTRICT BOUNDARY CHANGE FROM R-R TO R-R 10 USE FOR 40.91 ACRES IN SECTION 35, T37N, R110W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Dave L. and Beverly J. Hawks and Conway D. and Gloria Hawks filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from R-R to R-R 10 use, 40.91 acres, being that portion of the SE $\frac{1}{4}$ SW $\frac{1}{4}$  and SW $\frac{1}{4}$ SE $\frac{1}{4}$  West of the Cora-Kendall Road in Section 35, T37N, R110W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application was published in the Pinedale Roundup on October 27 and November 23, 1983;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Planning and Zoning Commission at 7:30 p.m. on December 1, 1983, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before said Board of County Commissioners was published in the Pinedale Roundup on December 15, 1983, and January 12, 1984;

WHEREAS, pursuant to said published notice a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on January 17, 1984, at which time said Board determined it would accept and act upon the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Dave L. and Beverly J. Hawks and Conway D. and Gloria Hawks to reclassify and rezone from R-R to R-R 10 use 40.91 acres in Section 35, T37N, R110W, Sublette County, Wyoming, is hereby approved.
