

RESOLUTION NO. 84-77B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF GERALD B. AND COLLEEN McELROY FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 TO R-R 5 DISTRICT FOR LOT 5 OF ANDERSON SUBDIVISION OF RECORD IN THE OFFICE OF THE CLERK OF SUBLINTE COUNTY, WYOMING.

WHEREAS, Gerald B. and Colleen S. McElroy filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to R-R 10 district, 10 acres, more or less, being Lot 5, Anderson Subdivision of record in the Office of the Clerk of Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application was published in the Pinedale Roundup on January 26 and February 23, 1984;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on March 1, 1984, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on March 15 and April 12, 1984;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on April 17, 1984, at which time said Board determined that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application with the stipulation that a right-of-way easement for access be granted to the south 5 acre tract.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Gerald B. and Colleen S. McElroy for a zoning district boundary change from A-1 to R-R 5 district for 10 acres, more or less, being Lot 5, Anderson Subdivision of record in said Office, is hereby approved.
