

## RESOLUTION NO. 84-94B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF BRUCE C. GOOCH, ET. AL. FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO R-R 10 DISTRICT FOR 80 ACRES, MORE OR LESS, BEING PART OF THE E1/2SE1/4, SEC. 1, T33N, R109W, SUBLLETTE COUNTY, WYOMING.

WHEREAS, Bruce C. Gooch, et.al. filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 to R-R 10 district, 80 acres, more or less, being part of the E1/2SE1/4, Sec. 1, T33N, R109W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on May 3 and 31, 1984;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on June 7, 1984, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that said application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on June 14 and July 12, 1984;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on July 17, 1984, at which time said Board determined that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Bruce C. Gooch, et.al. for a zoning district boundary change from A-1 district to R-R 10 district, 80 acres, more or less, being the E1/2SE1/4, Sec. 1, T33N, R109W, Sublette County, Wyoming, is hereby approved.
