

R E S O L U T I O N   N O .   85-2J

A RESOLUTION RATIFYING AND CONFIRMING CERTAIN ACTIONS TAKEN UNDER RESOLUTION NO. 84-91B, PROPOSING THE ESTABLISHMENT OF SUBLINTE COUNTY MOSQUITO ABATEMENT DISTRICT NO. 1 AND SETTING ITS BOUNDARIES, PROVIDING FOR AN ORGANIZATIONAL ELECTION AND CONDITIONING THE ESTABLISHMENT ON THE TOWN OF PINEDALE CREATING A SIMILAR DISTRICT IN ORDER THAT THE PURPOSE OF BOTH DISTRICTS MAY BE FUNDED AND MANAGED THROUGH A JOINT POWERS AGREEMENT BETWEEN SUCH DISTRICTS.

WHEREAS, Resolution No. 84-91B was adopted by the board on July 10, 1984.

WHEREAS, Section 18-12-122, W.S., 1977 requires an organizational election of property owners within the proposed district be held within 40 days after the adoption of the resolution, and for the election of three directors to serve on the initial board.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLINTE COUNTY, WYOMING:

1. That the actions taken by the board on July 10, 1984, under Resolution No. 84-91B, which are not inconsistent with the provisions of Section 18-12-122 are ratified, accepted and confirmed.

2. That within forty days after this date an election shall be held on the organization of the district, wherein the electorate in the proposed district shall vote to establish the district and to elect its first board of directors.

3. That the boundaries of the district as specified in Resolution 84-91B are incorporated herein by reference, with the same force and effect as though fully set forth herein.

4. That the board recommends the following persons be nominated to serve on the initial board of the district, subject to any additional nominations properly made:

Joe Hicks, who shall serve a five (5) year term.

Carolyn Abercrombie, who shall serve a four (4) year term.

Joe Simo, who shall serve a three (3) year term.

5. That each year, commencing with the third anniversary of the organizational election, an election shall be held to elect a director to fill the vacancy resulting from the expiration of the term of the director whose term expires at that time.

6. That any actions taken by the assessor in reliance on the provisions of Resolution 84-91B are hereby ratified, confirmed and approved.

7. That the election ballot shall clearly indicate that the district, if approved, shall become effective and operational only on the condition that the Town of Pinedale creates a similar district in order that both districts may fund and manage the mosquito abatement program through a joint powers agreement.
