

## RESOLUTION 85-11J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF JOSEPH AND JUANA GRAS FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO R-R 10 DISTRICT FOR 20.328 ACRES, MORE OR LESS, BEING THE W1/2NW1/4NW1/4, SECTION 7, T33N, R108W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Joseph and Juana Gras filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone lands from A-1 district to R-R 10 district, 20.328 acres, more or less, being the W1/2NW1/4NW1/4, Section 7, T33N, R108W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on November 29 and December 27, 1984;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30p.m. on January 3, 1985, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on January 17 and February 7, 1985;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on February 19, 1985, at which time said Board determined that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of John and Diane Awve for a zoning district boundary change from A-1 district to R-R 10 district of 20.328 acres, more or less, being the W1/2NW1/4NW1/4, Section 7, T33N, R108W, Sublette County, Wyoming, is hereby approved.
